We started the year with £58 and quite a lot of hope. We managed to:

- **Work with Wakefield District Children and Young People's Strategic Partnership to write a Complaints Policy and Code of Practice.**
- **Get a contract to deliver training to Connexions PAs: Practical Advocacy Techniques for Supporting Young People**
- **Create a website at www.advocacyaction.org.uk**
- **Supported Rasa Advocacy Project by working with their volunteers, and by being elected onto their committee**
